## The Felt Store “The Great Felt Pad Giveaway” Contest Rules & Regulations

The Felt Store “The Great Felt Pad Giveaway” contest is being run by The Felt Store, Inc. The Felt Store “The Great Felt Pad Giveaway” contest (herein referred to as “the contest”) is open to all Canadian and US residents, excluding residents of the states of Hawaii and Alaska, who have reached the age of majority in their province, territory, or state of residence. The contest is not open to minors, even with parent or guardian consent for entry into the contest. If a minor is selected as the contestant, they agree to forfeit their prize outright and a new contestant will be selected in their place.

The contest will take place on the Facebook website (<http://www.facebook.com>) and The Felt Store’s Facebook page (<http://www.facebook.com/TheFeltStore> ). Entries must be received between April 19, 2016 at 12:00am EST to May 2, 2016 at 11:59pm EST to be eligible for the contest, while supplies last. Maximum of one entry per person/Facebook account. Only the first 500 valid entries will receive The Felt Store’s Heavy Duty Felt Pad Kits (herein referred to as the “Felt Pad Kit”).

To enter the contest, you must have a valid Facebook account under your own name and you will be required to use this valid account. You are required to enter the contest using The Felt Store’s contest app on Facebook (<https://www.facebook.com/TheFeltStore/app/5157206118585523>). Using this app, you will be asked to “like” The Felt Store’s Facebook page using the “Like Page” option. You can opt out by using the “No, thank you” option. You will then be provided with a form to enter your name, email address and home shipping address. This information is required by The Felt Store in order to be able to send the prize. Failure to provide this information will be an agreement that you forfeit your prize outright and a new contestant will be selected in your place. Once this information is submitted, you will be asked to share the contest post from The Felt Store’s Facebook page using the “Share Post” option. You can opt out by using the “No, thank you” option. After completing these steps, you will be entered into the contest. Any other forms of entry will not result in eligible entries into the contest.

Contestants are selected to receive the Felt Pad Kit in order of entry into the contest in a first come, first serve fashion. Only the first 500 valid entries will receive the Felt Pad Kit. The Felt Pad Kit will be mailed from The Felt Store’s head office location (address stated above) using standard Canada Post/USPS mail (herein referred to as the “shipping accriers”) to the address submitted by the contestant. No tracking information will be provided.

If the selected contestant refuses to accept the prize or if the prize is lost in transit by the shipping carriers, the selected contestant forfeits their prize and releases The Felt Store, Facebook, Canada Post,

USPS and their employees, directors, and officers (herein referred to as “Third Party Service”) from any obligation toward the winner.
