The Felt Store “Golden Ticket” Contest Rules & Regulations

The Felt Store “Golden Ticket” contest is being run by The Felt Store, Inc. The Felt Store can be contacted by mail at The Felt Store Golden Ticket Contest, C/O The Felt Store, Inc., 2541 Wharton Glen Avenue, Mississauga, Ontario, L4X 2A8, Canada, by phone toll-free at 1-866-757-3358, or by email at salesinfo@thefeltstore.com.

The Felt Store “Golden Ticket” contest (herein referred to as “the contest”) is open to all Canadian and US residents, excluding residents of the province of Quebec, who have reached the age of majority in their province, territory, or state of residence. The contest is not open to minors, even with parent or guardian consent for entry into the contest. If a minor is selected as the contestant, they agree to forfeit their prize outright and a new contestant will be selected in their place.

To enter the contest, you will be required to place an order online with The Felt Store directly through <http://www.thefeltstore.com> between November 24, 2014 and December 17, 2014. Orders placed over the phone, or through a Third Party website, are not eligible for entry into the contest. Once the order is placed, you will automatically be entered into the contest. No additional information or additional actions are required. Orders are selected to receive The Felt Store “Golden Ticket” (herein referred to as the “Golden Ticket”) at random by the staff of The Felt Store. Odds of receiving the Golden Ticket depend on the number of orders placed between November 24, 2014 and December 17, 2014 inclusive. The Golden Ticket and a copy of the contest instructions will be included in the randomly selected order package for receipt by the selected contestant.

To be declared the winner, the selected contestant must first upload/post a picture of themselves with the Golden Ticket to either The Felt Store’s Twitter page (<http://twitter.com/TheFeltStore>), Facebook page (<http://www.facebook.com/TheFeltStore>) or Google+ page (<http://plus.google.com/+TheFeltStoreMississauga>) by December 31, 2014. Once the picture is posted, The Felt Store will acknowledge the selected contestant as the winner publicly on the social media platform used by the selected contestant and the selected contestant will be required to contact The Felt Store by phone at 1-866-757-3358 to answer the skill testing question, which is included in the contest instructions, by December 31, 2014. Once the skill testing question is correctly answered, The Felt Store will provide the selected contestant (now considered the winner) with a coupon code prize that can be used to redeem up to \$100.00 USD on The Felt Store website (www.thefeltstore.com), excluding shipping and taxes (herein referred to as “coupon code prize”). The coupon code prize cannot be combined and is not valid with any other offers or discounts provided by The Felt Store on <http://www.thefeltstore.com> at the time of use of the coupon code.

The coupon code prize will be valid from the date of issue until December 31, 2015, at which point it will expire and the winner forfeits the value of the coupon code prize. If the selected contestant refuses to accept the prize, refuses to post a picture or refuses to contact The Felt Store after being acknowledged
