The Felt Store “Tag & Win!” Contest Rules & Regulations

The Felt Store “Tag & Win!” contest is being run by The Felt Store, Inc. The Felt Store can be contacted by mail at The Felt Store Tag & Win!, C/O The Felt Store, Inc., 2541 Wharton Glen Avenue, Mississauga, Ontario, L4X 2A8, Canada, by phone toll-free at 1-866-757-3358, or by email at salesinfo@thefeltstore.com.

The Felt Store “Tag & Win!” contest (herein referred to as “the contest”) is open to all Canadian and US residents, excluding residents of the states of Hawaii and Alaska, who have reached the age of majority in their province, territory, or state of residence. The contest is not open to minors, even with parent or guardian consent for entry into the contest. If a minor is selected as the contestant, they agree to forfeit their prize outright and a new contestant will be selected in their place.

The contest will take place on the Facebook website (<http://www.facebook.com>) and The Felt Store’s Facebook page (<http://www.facebook.com/TheFeltStore>). Entries must be received between June 13, 2016 at 12:00am EST to July 3, 2016 at 11:59pm EST to be eligible for the contest, while supplies last. Maximum of one entry per person/Facebook account. One (1) winner will be randomly selected every Friday that the contest is run by The Felt Store staff.

To enter the contest, you must have a valid Facebook account under your own name and you will be required to use this valid account. You are required to enter the contest using the contest post (titled “Tag Dad and Win!”) on The Felt Store’s Facebook page. Using this contest post, you will be required to tag a different individual with a valid Facebook account under their own name. This tagged Facebook account must belong to a different individual under their own name. Tags for multiple accounts owned by the same individual will not be accepted and the entries will be considered invalid, making the individual ineligible to be selected for the prize. After completing these steps, you will be entered into the contest. Any other forms of entry will not result in eligible entries into the contest.

If the selected contestant refuses to accept the prize, refuses to provide a shipping address for the prize when requested by The Felt Store staff, or if the prize is lost in transit by the shipping carriers, the selected contestant forfeits their prize and releases The Felt Store, Facebook, Canada Post, USPS and their employees, directors, and officers (herein referred to as “Third Party Service”) from any obligation toward the winner.

If a selected contestant enters the contest in a way not outlined in this document or declines the prize, the prize shall be forfeited and The Felt Store has the right, at its sole discretion, to select another winner.

The selected contestant may be required to provide proof of age or proof of province, state, or territory of residence prior to receiving the Felt Overshoes. The selected contestant may also be required to sign a release declaring their eligibility as stipulated in these rules; and releasing The Felt Store and its

employees, as well as the Third Party social media services and shipping carriers outlined above and their directors, officers, and employees from all liability for any damage or loss arising from participation in the contest or from the awarding, acceptance or use of the Felt Overshoes. The Felt Overshoes shall be accepted as is and may not be exchanged or refunded for any amount of money, sold or transferred. No substitutions will be allowed.
